The Undersigned subordinator and owner agree as follows:

- 1. Boeing Employees' Credit Union referred to herein as "subordinator", is the owner and holder of a mortgage dated ____02/26/2021_____ which is recorded in Book _____ Page _____ under auditor's file no. 2021-003644 of Klamath County.
- 2. Boeing Employees' Credit Union referred to herein as "lender" is the owner and holder of the mortgage dated May 22, 2023 executed by Gordon Scott McCreadie (which is recorded in volume of Mortgages, page ____ under auditor's file no. _______________________ records of Klamath County) (which is to be recorded concurrently herewith.)
- 3. Gordon Scott McCreadle referred to herein as "owner", is the owner of all the real property described in the mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged, and to induce "lender" to advance funds under its mortgage and all agreements in connection therewith, the "subordinator" does hereby unconditionally subordinate the lien of his/her mortgage, identified in Paragraph 1 above to the lien of "lender's" mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
