Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:


A tract of land located in the NE 1/4 NW 1/4 of Section 18, Township 38 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at a point on the Easterly right of way line of the Old Dalles California Highway which bears North 89°42' West 710.5 feet and South 6°02' West 855.0 feet from the North quarter corner of said Section 18; thence South 89°09' East 328.04 feet, thence South 6°02' West 448.10 feet, more or less, to a point on the North line of Terminal City; thence South 89°41' West along the North line of Terminal City 229.11 feet; thence North 0°23' East 38.60 feet; thence North 71°25' West 257.05 feet, more or less, to the Westerly right of way line of the said Old Dalles California Highway; thence along the said Westerly right of way line on the arc of a curve to the left (central angle 32°50', centerline radius 716.5 feet) to a point on the Easterly right of way line of the State Road (long chord of this segment bears North 37°01' East 16.6 feet); thence along the Easterly line of said State Road on the arc of a curve to the left (central angle 28°27' centerline radius 311.5 feet, long chord bears North 52°00' East 153.0 feet) to the point of intersection with the Easterly right of way line of said Old Dalles California Highway, thence along Easterly right of way line of said Old Dalles California Highway on the arc of a curve to the left (central angle 32°50', centerline radius 716.5 feet) long chord of this segment bears North 20°25' East 144.83 feet; thence continuing along said Easterly right of way line North 6°02' East 100.0 feet, more or less to the point of beginning.
