THIS INDENTURE, Dated April 11, 2023, between Andrew C. Brandsness, hereinafter called trustee, and Kent Taylor, as Beneficiary, hereinafter called the second party;

## WITNESSETH:

RECITALS: Abraham Vera Enriquez, as to an undivided  $\frac{1}{2}$  interest and Jose Gilberto Sanchez Escalante, as to an undivided  $\frac{1}{2}$  interest, as Tenants in Common, as grantor, executed and delivered to Andrew C. Brandsness, as trustee, for the benefit of Kent Taylor, as beneficiary, a certain trust deed dated November 23, 2021, duly recorded on December 14, 2021, in the mortgage records of Klamath County, Oregon, in book/reel/volume No. 2021, at page 018474. In that trust deed the real property therein and hereinafter described was conveyed by the grantor to the trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary. If the foreclosure proceedings were stayed and released from the stay, copies of an amended notice of sale in the form required by ORS86.782(6) were mailed by registered or certified mail to the last known address of those persons listed in ORS 86.764 and 86.774(1) and to the address provided by each person who was present at the time and place set for the sale which was stayed within 30 days after the release from the stay. The last publication of the notice occurred more than twenty days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.764(1)(b) or (1)(c).

The true and actual consideration for this conveyance is \$25,000.00.

The undersigned trustee, on March 1, 2023, at the hour of 10:00 a.m. standard time, and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by said trust deed, sold the real property in one parcel at public auction to the second party for the sum of \$25,000.00, the second party being the highest and best bidder at the sale, and that sum being the highest and best sum bid for the property.

NOW THEREFORE, in consideration of the said sum so paid by the second party in cash, the receipt whereof is acknowledged, and by the authority vested in said trustee by the laws of the state of Oregon and by said trust deed, the trustee does hereby convey unto the second party all interest which the grantor had or had the power to convey at the time of grantor's execution of the trust deed, together with any interest the grantor or his successors in interest acquired after the execution of said trust deed in and to the following described
