KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

Lots 2 and 3, Block 4, NORTH KLAMATH FALLS ADDITION, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, EXCEPTING that portion lying in US Highway 97.

The true consideration for this conveyance is To Convey Title.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
