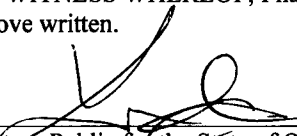

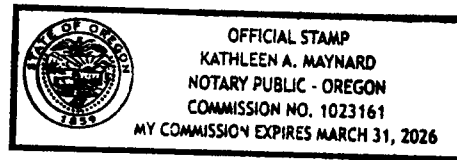


Exhibit "A"
Legal Description

In Township 40 South, Range 8 East, Willamette Meridian, Klamath County Oregon:

Section 17: The SW1/4 NW1/4

Together with the East 60 feet of the NW1/4 NW1/4 lying Southwesterly of the Keno Worden Highway.

Section 18: The NW1/4 NE1/4; The S1/2 NE1/4
