hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

The east 1/2 of the east half of the northeast quarter of the southeast quarter of Section 34, Township 35 South, Range 11 East, Willamette Meridian, consisting of ten acres, and subject to covenants, reservations and easements of record (if any,) and reserving 15 feet along the south side of the 10 acres for road easement.
