Lots 1 and 2, SUMMERS PARK, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

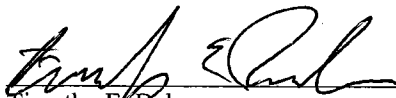
The true consideration for this conveyance is to convey title.

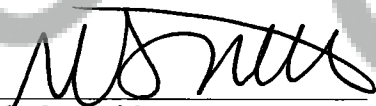
