KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto **Danish Holding LLC**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

**Description of real property:** A parcel of land situated in Section 6, Township 36 South, R13 E.W.M. Klamath County, Oregon being more particularly described as follows: Commencing at the Northeast corner of said Section 6; thence S 89 degrees 55' 50" W along the Northerly line of said Section 6; thence 328.33 feet; thence leaving said Northerly section S20 degrees 24' 00" W, 1120.93 feet to the point of beginning for this description; thence continuing S20 degrees 24' 00" W, 332.31 feet; thence N69 degrees 36' 00" W 655.40 feet; thence N 20 degrees 24' 00" E, 332.31 feet; thence S69 degrees 36' 00" E 655.40 feet to the point of beginning containing 5.00 acres more or less. 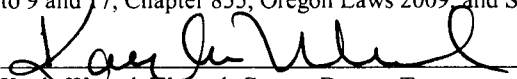
To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

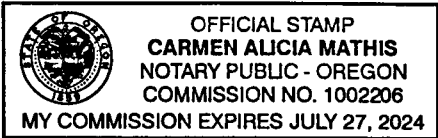

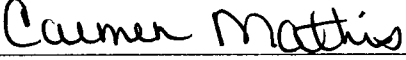
