## **GENERAL POWER OF ATTORNEY**

KNOW ALL MEN BY THESE PRESENTS, That I, **ARLENE NINNEMAN**, have made, constituted and appointed and by these presents do make, constitute and appoint **DAVID NINNEMAN** my true and lawful attorney in fact ("my attorney"), for me and in my name, place and stead and for my use and benefit,

- 1. Support. Make expenditures for my health, support, maintenance, and general welfare:
- 2. Granting permission to authorize medical, dental and/or vision care for me, and to make other important decisions on my behalf in the event of an illness or injury;
- 3. To lease, let, grant, bargain, sell, contract to sell, convey, exchange, remise, release and dispose of any real or personal property of which I am now or hereafter may possess or in which I may have any right, title or interest, for any price or sum and upon such terms and conditions as my attorney may deem proper;
- 4. To take possession of, manage, maintain, operate, repair, and improve any and all real or personal property now or hereafter belonging to me, to pay any expense therefore, to insure and keep the same insured, and to pay any and all taxes, assessments and other charges that may be levied or imposed upon any of said property;
- 5. To buy, sell, and deal generally with any goods, wares and merchandise of every name, nature and description and to hypothecate, pledge, and encumber the same;
- 6. To buy, sell, assign, transfer and deliver all or any shares of stock in my name in any corporation for any price and upon such terms as to my attorney may deem right and proper and to receive and make payment therefore;
- 7. To borrow any sums of money on such terms and at such rate of interest as to my attorney may deem proper and to give security for the repayment of the same;
- 8. To ask for, demand, recover, collect and receive all moneys, debts, rents, dues, accounts, legacies, bequests, interests, dividends and claims whatsoever which are now or which hereafter may become due, owing and payable or belonging to me and to have, use and take any and all lawful ways and means in my name for the recovery of thereof by attachments, levies or otherwise;
- 9. To prepare, execute and file any proof of debt and other instruments in any court and to take any proceedings under the Bankruptcy Act in connection with any sum of money or demand due or payable to me and in any such proceedings to vote in my name for the election of any trustee(s), and to demand, receive and accept any dividend or distribution whatsoever;

- 10. To adjust, settle, compromise or submit to arbitration any account, debt, claim, demand or dispute as well as matters which are now existing or hereafter may arise between me or my attorney and any other person or persons:
- 11. To sell, discount, endorse, negotiate, and deliver any check, draft, order, bill of exchange, promissory note or other negotiable paper payable to me, and to collect, receive and apply the proceeds thereof for my use for any of the purposes aforesaid; to pay to or deposit the same or any other sum of money coming into the hands of my attorney in checking and/or savings accounts in my name with any bank or banker of my attorney's selection and to draw out moneys deposited to my credit with any bank, by check or otherwise, including deposits in savings accounts, and to apply the same for any of the purposes of my business as my attorney may deem expedient; to purchase and sell certificates of deposit; to appoint any bank or trust company as escrow agent; to transfer any asset of mine into any form or sort of trust; generally to conduct any and all banking transactions on my behalf;
- 12. To commence and prosecute and to defend against, answer and oppose all actions, suits and proceedings concerning any of the matters detailed above or any other matters in which I am or hereafter may be interested or concerned;
  - 13. To vote any stock in my name as proxy;
- 14. To have access to any safety deposit box which has been or may be rented in my name or in the name of myself and any other person or persons;
- 15. In connection with any of the powers herein granted, to sign, make, execute, acknowledge, and deliver in my name any and all deeds, contracts, bills of sale, leases, promissory notes, drafts, acceptances, evidences of debt, obligations, mortgages, pledges, satisfactions, releases, acquittances, receipts, bonds, writs, and any and all other instruments whatsoever, with such general or special agreements and covenants, including those of warranty, as my attorney may deem right, proper and expedient;
- 16. To employ, pay and discharge any person, including counsel and attorneys in connection with the exercise of any of the foregoing powers;
