The true and actual consideration for this conveyance is \$630,000.00.

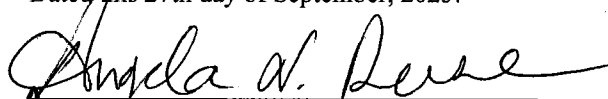

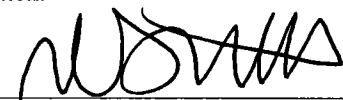

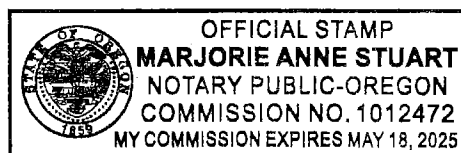
