Lot 35, Tract 1416, the Woodlands, Phase 1, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

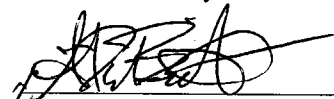

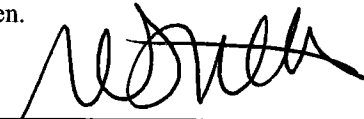
