THIS INDENTURE, made 10/13/2023, between CLEAR RECON CORP hereinafter called trustee, and Robert Hosking, hereinafter called the second party:

WITNESSETH:

RECITALS: ROBERT F. GARCIA, as grantor, executed and delivered to AMERITITLE, LLC, for the benefit of MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS DESIGNATED NOMINEE FOR GATEWAY BUSINESS BANK, DBA MISSION HILLS MORTGAGE BANKERS, BENEFICIARY OF THE SECURITY INSTRUMENT, ITS SUCCESSORS AND ASSIGNS, as beneficiary, a certain Trust Deed dated 5/22/2008, duly recorded on 5/29/2008, as Instrument No. 2008-007855, in the mortgage records of Klamath County, Oregon.

In said Trust Deed the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the said beneficiary.
