To have and to hold the same unto grantee and grantee's heirs, successors, and assigns forever.

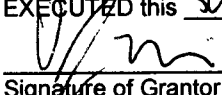
The true and actual consideration paid for this transfer, stated in terms of dollars, is **\$ 10,000.00**

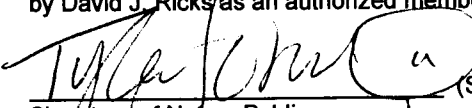
