PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 20 day of October, 202 by and between

Michael Scott McGregor the duly appointed, qualified and acting personal representative of the estate of <u>David Glenn McGregor</u>, deceased, Probate Case No. 23PB05619, filed in Klamath County,

hereinafter called the first party, and

Janevit Warapattananond,

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot 10 in Block 2, REPLAT OF BUREKER PLACE and the Westerly 10 feet of Lot 16 in Block 4, FIRST ADDITION TO BUREKER PLACE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$253,700.00. However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.
