Government Lots 10 and 15, Section 32, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

EXCEPTING THEREFROM that portion within Highway 427

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
