SUBORDINATION AGREEMENT

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- Washington Federal, N.A., a National Association referred to herein as 'subordinator', is the Owner and holder of a Mortgage dated May 03, 2022, which is recorded under auditor's file NO. 2022-006109 records of Klamath County, Oregon.
- 2. Creferred to herein as 'lender', is the owner and holder of a Mortgage dated 113133 executed by Tracy Ledgerwood and Martin Ledgerwood, wife and husband which is recorded under Auditor's File No. 2033-091559 records of Klamath County, Oregon.
- Tracy Ledgerwood and Martin Ledgerwood, referred to herein as 'owner', is the owner of all the real property described in the Mortgage identified above in Paragraph 2.
- 4. In consideration of benefits to 'subordinator' from 'owner', receipt and sufficiency of which is hereby acknowledged, and to induce 'lender' to advance funds under its Mortgage and all agreements in connection therewith, the 'subordinator' does hereby unconditionally subordinate the lien of his Mortgage identified in Paragraph 1 above to the lien of "lender's" Mortgage, identified in Paragraph 2 above, and all advances or charges made or accruing thereunder, including any extension or renewal thereof.
