A SPECIAL ORDINANCE TO TERMINATE A RESERVED UTILITY EASEMENT **CREATED THROUGH SECTION 3 OF ORDINANCE NO. 6085** FOR AN AREA EAST OF FAIRMOUNT STREET

WHEREAS, the Klamath Falls City Council passed Ordinance No. 6085 on September 20th, 1976:

WHEREAS, Ordinance No. 6085 was thereafter recorded on September 28, 1976 in Volume M76, Page 15222 of Klamath County, Oregon records;

WHEREAS, Section 3 of Ordinance No. 6085 vacated the alley within Block 15 of the Mountain View Addition while reserving to the City of Klamath Falls a 16-foot wide easement for public utility purposes;

WHEREAS, property owners Hillary and Logan Koehler, through the submission of Land Partition 34-23, have requested to terminate the Reserved Utility Easement created through Section 3 of Ordinance No. 6085:

WHEREAS, City staff evaluated the request and determined no City utilities are located within the Reserved Utility Easement created through Section 3 of Ordinance No. 6085;

WHEREAS, City staff determined the Reserved Utility Easement created through Section 3 of Ordinance No. 6085 is not necessary for the placement of future City utilities;

WHEREAS, all City franchise utilities were properly noticed regarding the termination of the Reserved Utility Easement created through Section 3 of Ordinance No. 6085 and no objection was received; and NOW THEREFORE,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

The Reserved Utility Easement created through Section 3 of Ordinance No. 6085, as depicted within the map attached hereto as Exhibit A, is hereby terminated.

The reserved utility easements created through Sections 1 and 2 of Ordinance No. 6085 shall remain inplace, as does the remainder of the Ordinance except for Section 3.

This Ordinance shall become effective 30 days from enactment.
