The true and actual consideration for this conveyance is \$3,000.00.

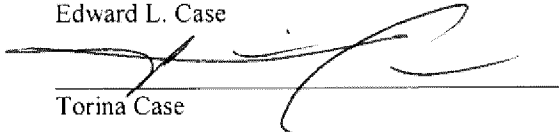

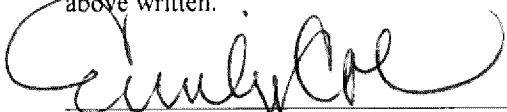
