PARCEL 1:

Beginning at a point North 38°56' East a distance of 164 feet from the Easterly corner of Block 78 in Klamath Addition to the City of Klamath Falls, Oregon; thence North 51°4' West 100 feet, thence North 38°56' East 52 feet; thence South 51°4' East 100 feet thence South 38°56' West 52 feet to the point of beginning, being a portion of the NE1/4 NE1/4 of Section 32, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.

PARCEL 2:
