#### **ASSIGNMENT AND ASSUMPTION OF EASEMENTS**

## **GRANTEE: TP HoldCo Development, LLC**

This Assignment and Assumption of Easements (this "<u>Assignment</u>"), effective as of the 22<sup>nd</sup> day of January, 2024 (the "<u>Effective Date</u>"), is by and between Pacific Connector Gas Pipeline, L.P., a Delaware limited partnership ("<u>Assignor</u>"), and TP HoldCo Development, LLC, a Delaware limited liability company ("<u>Assignee</u>").

WHEREAS, Assignor, Assignee and certain other parties thereto have entered into that certain Framework Agreement, dated as of October 15, 2023 (the "Framework Agreement"), pursuant to which, among other things, Assignor has agreed to convey and assign to Assignee, and Assignee has agreed to accept from Assignor, Assignor's right, title and interest in and to the rights-of-way and easements recorded in Klamath County, State of Oregon, described on Exhibit A attached hereto (collectively, the "Easements");

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

- 1. <u>Definitions</u>; Recording. All capitalized terms used in this Assignment but not otherwise defined herein are given the meanings set forth in the Framework Agreement. Pursuant to ORS 205.236(2)(b), this instrument is being recorded to document the assignment of all of the Easements described below, in lieu of an individual assignment of each Easement.
- 2. <u>Assignment</u>. Assignor hereby sells, assigns, grants, conveys and transfers to Assignee all of Assignor's right, title and interest in and to the Easements.

- 3. <u>Assumption</u>. Assignee hereby accepts such assignment and assumes and agrees to pay, perform and discharge, as and when due, all of the Assumed Liabilities with respect to such Easements.
- 4. <u>Restrictions</u>. Notwithstanding anything to the contrary in this Assignment, this Assignment shall not constitute an assignment of, or otherwise transfer, any Easements if such assignment or transfer: (i) violates applicable Law; (ii) explicitly requires the consent or waiver of a Person who is not a party to this Assignment or an Affiliate of a party to this Assignment and such consent or waiver has not been obtained prior to the Effective Date; or (iii) is not assignable on its terms (each, a "<u>Restriction</u>"). When and if such Restriction is satisfied, waived or removed or becomes otherwise inoperable or unenforceable, the assignment of such portion of the Easements as may be subject thereto shall become effective automatically as of the Effective Date, without further action on the part of Assignor or Assignee.
- 5. <u>Terms of the Framework Agreement</u>. The terms of the Framework Agreement are incorporated herein by this reference. In the event of any conflict or inconsistency between the terms of the Framework Agreement and the terms hereof, the terms of the Framework Agreement shall govern; *provided that*, <u>Section 6</u> of this Assignment shall control with respect to the governing law of this Assignment.
- 6. <u>Governing Law</u>. This Assignment shall be governed by and construed in accordance with the laws of the state of Oregon.
- 7. <u>Counterparts</u>. This Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement.
