The true and actual consideration for this conveyance is estate distribution.

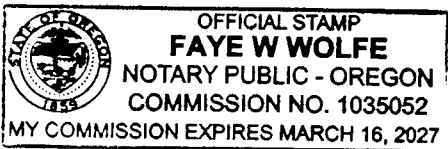
