MEMORANDUM OF GROUND LEASE AGREEMENT

THIS MEMORANDUM OF GROUND LEASE AGREEMENT is entered into as of May 3, 2024 between the KLAMATH HOUSING AUTHORITY, a public body corporate and politic of the State of Oregon ("Landlord"), and MOUNTAINVIEW TOWNHOMES LIMITED PARTNERSHIP, an Oregon limited partnership ("Tenant"), and with reference to the following facts:

- A. Landlord and Tenant entered into that certain unrecorded Ground Lease Agreement dated as of May 3, 2024 ("Ground Lease Agreement"). The Ground Lease Agreement covers all those certain tracts of land (collectively, the "Land"), in Klamath County, Oregon which are described in Exhibit A attached hereto, together with any and all easements, rights-of-way, driveways and appurtenances, to the same belonging or in any way appertaining (all of which, together with the Land, are hereinafter referred to collectively as the "Premises"), excluding any and all Improvements and Equipment now or hereafter located thereon. All capitalized terms used and not defined herein have the meanings set forth in the Ground Lease Agreement.
- B. Landlord and Tenant desire to record this Memorandum of Ground Lease Agreement in order to impart notice of the Ground Lease Agreement to the public.

NOW, THEREFORE, the parties hereto agree as follows:

- 1. Pursuant to the Ground Lease, the Landlord has leased to the Tenant and Tenant has leased from Landlord the Premises.
- 2. The term of the Ground Lease Agreement commenced on May 3, 2024 (the "Commencement Date"), and, subject to the applicable terms and provisions of the Ground Lease Agreement, ends on May 3, 2123.
- 3. This memorandum is prepared for the purpose of recordation to give notice of the Ground Lease Agreement. This memorandum shall not constitute an amendment or modification of the Ground Lease Agreement, and in the event of any conflict between the terms of this memorandum and the Ground Lease Agreement, the terms of the Ground Lease Agreement shall control.
