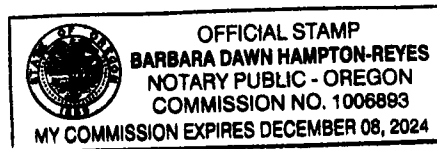


Exhibit A
