# SECOND AMENDMENT TO MEMORANDUM OF HYDROELECTRIC FACILITIES AND ROAD ACCESS EASEMENT AGREEMENT

A. - 3. This Amended Memorandum is executed and recorded solely for the purpose of providing record notice to third parties of the amended terms of the Easement and Memorandum of Easement. In the event of any conflict between any term or provision of the Easement and this Amended Memorandum, the applicable term or provision of the Easement shall control. Reference is made to the Easement for all remaining terms, covenants, and conditions thereof.
- 4. This Amended Memorandum may be executed in separate counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same Amended Memorandum.
