A portion of Lot 7, Block 4 of TRACT 1019, WINEMA PENINSULA - UNIT 2, in the County of Klamath, State of Oregon, and being more particularly described as follows:

Beginning at a point on the South line of said Lot 7, said point being North 89° 50' 08" West 163.00 feet from the Southeast corner of said Lot 7;

thence North 246.76 feet;

thence North 53° 29' 14" East 171.79 feet to the right of way line of the Cul-De-Sac of Annie Court; thence Westerly along the arc of said cul-de-sac (radius bears North 29° 54' 33" East 50.00 feet, central angle is 23° 34' 41") 20.58 feet to the most Northerly corner of said Lot 7;
