Parcel 1 of Land Partition 9-16, situated in Government Lots 3, 6, 11, 14 and a portion of Government Lots 12 and 13 (NW1/4) of Section 3, Township 36 South, Range 7 East of the Willamette Meridian, Klamath County Oregon, being more particularly described as follows:

Beginning at the Northwest corner of said Government Lot 3; thence North 89°49'37" East, along the North line of said Lot 3, 706.04 feet; thence, leaving the said North line, South 02°50'54" East 2039.15 feet; thence East 424.00 feet to a point on the East line of said Government Lot 14; thence South 01°55'51" West 612.33 feet, more or less, to the Southeast corner of said Lot 14; thence West, along the South line of Government Lots 14 and 13, 2075.7 feet, more or less, to the Easterly right of way line of the Union Pacific Railroad; thence North 10°19'04" West, along the said Easterly right of way line, 1346.99 feet to the North line of said Government Lot 12; thence East, along the North line of said Lot 12, 1063.4 feet, more or less, to the Southwest corner of said Government Lot 6; thence North 01°55'51" East, along the West lines of Government Lots 6 and 3, 1322.04 feet to the point of beginning.
