BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That **Joann R. Pierce,**

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto **Jerome Douglas Pierce,**

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath,** State of Oregon, described as follows, to wit:

Lot 5 in Block 13, OREGON SHORES SUBDIVISION- Tract #1053, in the County of Klamath, State of Oregon, as shown on the map filed on October 3,1973, in Volume 20, pages 21 and 22 of MAPS in the office of the County Clerk of said County.

The true and actual consideration paid for this transfer, stated in terms of dollars, is to convey title. However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
