SUBSTITUTION OF TRUSTEE AND DEED OF RECONVEYANCE

The original note and trust deed that is subject to this deed of reconveyance was between Marvin Sullivan, as grantor, Michael T. Polsan as the initial trustee, and James Gustafson as original beneficiary recorded April 22, 1994, under the recording at Vol. M94, page 12012, Mortgage records of Klamath County, Oregon.

The original trust deed was assigned from James Gustafson to his wife, Bettie Gustafson pursuant to Small Estate case number 9504249CV. See attached small estate affidavit. An assignment was never recorded; however, the estate did record a bargain and sale deed attempting to transfer the interest in the trust deed. This is also attached. At the time of recording the bargain and sale deed, the real property was already owned in fee simple by Marvin Sullivan, and the only purpose of the recording would have been to assign the trust deed as outlined in the small estate affidavit. The estate was closed on May 23, 1996.

Bettie Gustafson then passed away and her interest in the trust deed was probated and assigned to Richard James Gustafson, Vicki Lynn Gordon, Craig Gustafson, as reflected in document number 47478, Volume M97, page 34951.

Craig Gustafson died, and his estate was never probated. Nicole Heryford and Ryan Gustafson are his only heirs as reflected in the attached affidavit of heirship signed by both of them.

Therefore, the current beneficiaries of the trust deed are Richard James Gustafson, Vicki Lynn Gordon, Nicole Heryford and Ryan Gustafson. They each request that Katheryn Ireland be appointed as successor trustee. They each have requested that the trust deed be reconveyed as the note and all amounts payable under the note and trust deed have been paid in full. Katheryn Ireland, an Oregon Attorney, hereby accepts said appointment as Trustee under the above Deed of Trust as substitute trustee, pursuant to the request of the present Beneficiaries and in accordance with the provisions of said Deed of Trust, does hereby reconvey without warranty, to the person or persons legally entitled thereto, all the estate now held by them under the Deed of Trust.






