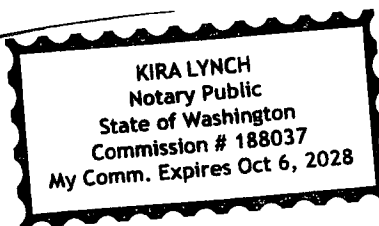

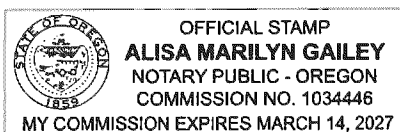

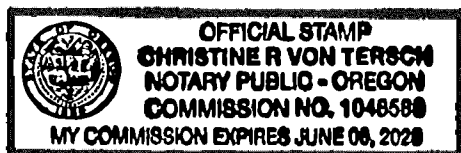

This notice is about your mortgage loan on your property at 3152 Madison St, Klamath Falls, OR 97603

Your lender has decided to sell this property because the money due on your mortgage loan has not been paid on time or because you have failed to fulfill some other obligation to your lender. This is sometimes called 'foreclosure'.

The amount you would have had to pay as of July 12, 2024 was \$24,075.67. The amount you must now pay to bring your loan current may have increased since that date.

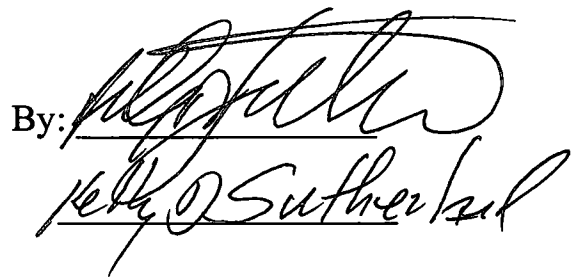

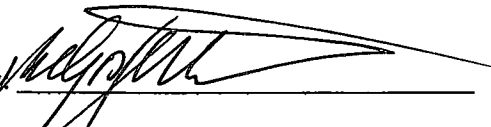

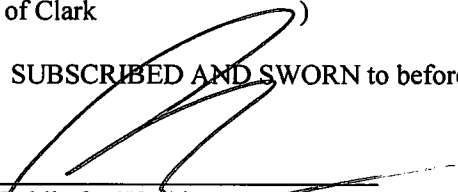
