3. The object of the action is the foreclosure of a mortgage recorded in the official records of Klamath County, Oregon, as Document No. 2011-008083;

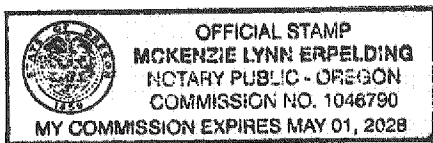
