WARRANTY DEED

KNOW ALL BY THESE PRESENTS that GARY E. MULVEY, who acquired title as GARY EUGENE MULVEY, RHONDA R. MULVEY and HEATHER MICHELLE MERRIHEW, hereinafter called grantor, for the consideration hereinafter stated, to grantor paid by GARY E. MULVEY, TRUSTEE, OR HIS SUCCESSORS IN TRUST, UNDER THE GARY E. MULVEY LIVING TRUST DATED OCTOBER 14, 2024, AND ANY AMENDMENTS THERETO, hereinafter called grantee, do hereby grant, bargain, sell and convey unto grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in **Klamath** County, State of Oregon, described as follows, to-wit:

Lot 8, Block 2, Tract No. 1088, Ferndale, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

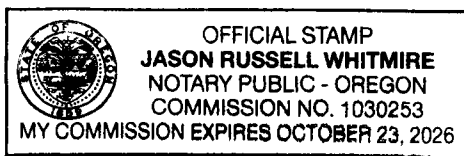

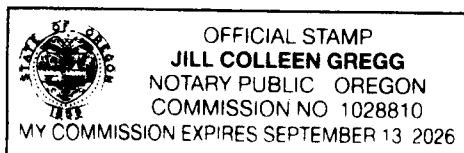
