LOT 113 TRACT 1277, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.



In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.



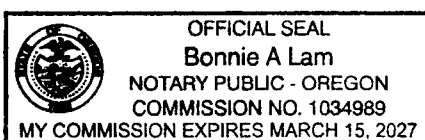
