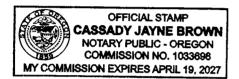
THIS SUPPLEMENT TO AMENDED AND RESTATED DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RUNNING Y RANCH RESORT (the "Consolidation Declaration") is dated as of January 21, 2025, by RUNNING Y RANCH DEVELOPMENT, LLC, an Oregon limited liability company, successor declarant to CLV PROPERTIES, LLC, an Oregon limited liability company ("Declarant"), and by LINDA GOODWIN ("Owner").

RECITALS

- A. Declarant is the declarant of the Amended and Restated Declaration of Protective Covenants, Conditions, Restrictions and Easements for Running Y Ranch Resort recorded June 20, 2018 in the Records of Klamath County, Oregon, Document No. 2018-007433 (the "**Declaration**"), as amended by supplemental declarations thereto recorded in the records of Klamath County, Oregon. All capitalized terms used in this Consolidation Declaration and not otherwise defined herein shall have the meanings given to such terms in Article 1 of the Declaration.
- B. Owner owns Lot 708, as depicted on the Plat of Running Y Resort Phase 9, Klamath County, Oregon, referred to herein as "Lot 708". Owner also owns Lots 709 and 710, Running Y Resort Phase 9, Klamath County, Oregon, which lots were vacated by Klamath County by Final Order OR2021-090 dated June 22, 2021, referred to herein as the "Consolidated Lot".
- C. Lot 708 and the Consolidated Lot, now described as Land Partition 29-24 filed November 6, 2024 in the Office of the Klamath County Surveyor, are together referred to herein

as the "Adjoining Lots". Pursuant to Section 3.4 of the Declaration, the owner of adjoining Lots, with the approval of Declarant and the Architectural Review Committee, may elect to consolidate such Lots into one Lot. The Owner of the Adjoining Lots wishes to consolidate the Adjoining Lots into one Lot pursuant to Section 3.4 of the Declaration and as provided in this Consolidation Declaration. Declarant has consented to such consolidation.

NOW, THEREFORE, in furtherance of such intent, Declarant and Owner hereby declare that the Adjoining Lots shall be consolidated into one Lot for all purposes of the Declaration, including voting rights and assessments, effective as of the 6th of November, 2024.
