MEMORANDUM OF OPTION FOR LAND LEASE

(COMMUNITY SOLAR)

This Memorandum of Option for Land Lease (Community Solar) (the "Memorandum") is made an entered into as of February 24, 2025 by and between Tower Shopping Center of Klamath Falls, LLC, an Oregon limited liability company ("Grantor"), and SolaRay #1, LLC, an Arizona limited liability company ("Grantee").

WITNESSETH:

Grantor and Grantee are parties to that certain Land Lease Option (Community Solar) dated concurrently herewith ("Option"), whereby Grantor has granted to Grantee an exclusive option to lease portions of that real property in Klamath County described in the attached Exhibit "A," which is hereby incorporated by this reference (the "Property").

<u>Conflicts with Option</u>. This Memorandum is solely for notice and recording purposes and may not be construed to alter, modify, expand, diminish, or supplement the provisions of the Option. In the event of any inconsistency between the provisions of this Memorandum and the provisions of the Option, the provisions of the Option will govern.

<u>Counterparts</u>. The Memorandum may be executed in multiple counterparts.
