## PARCEL 1

A parcel of land located in approximately the Southeast corner of the SW 1/4 of the NW 1/4 of Section 3, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, further described as follows:

Commencing at the center of the intersection of the Malin Loop Road and the Malin Dump Road and extending thence North along the center line of said Malin Dump road 150 feet, more or less, to the North bank of "Malin High Line Canal", the true point of beginning; extending thence North along the center line of said Malin Dump Road, which is also the East line of the said SW 1/4 NW 1/4, a distance of 290 feet; thence West at right angles a distance of 205 feet; thence South parallel to the East line of said SW 1/4 NW 1/4, 175 feet, more or less, to the North bank of said Malin High Line Canal; thence Easterly along the North bank of said canal to the true point of beginning.

## PARCEL 2

In Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon.

All that portion of the South half of the SW 1/4 of the NW 1/4 of Section 3 and of the South half of the SE 1/4 of the NE 1/4 of Section 4 lying North of the "Malin High Line Canal".

EXCEPTING THEREFROM a parcel of land, more or less, heretofore sold to R.T. Parker and Ethel G. Parker, husband and wife, by contract dated December 1, 1961, recorded August 9, 1962 in Deed Volume 339 at page 321, and re-recorded November 8, 1963 in Deed Volume 349 at page 201 of Deed Records of Klamath County, Oregon.
