THIS INDENTURE, made 4/17/2025, between CLEAR RECON CORP hereinafter called trustee, and DPW Enterprises LLC & Push & Pull Homebuilder & Contractors LLC, hereinafter called the second party:

WITNESSETH:

RECITALS: FREDRICK W. FORSYTHE, as grantor, executed and delivered to WELLS FARGO FINANCIAL NATIONAL BANK, for the benefit of WELLS FARGO BANK, NATIONAL ASSOCIATION, as beneficiary, a certain Trust Deed dated 5/16/2005, duly recorded on 5/20/2005, in Book M05, Page 37078, the subject Deed of Trust was modified by Loan Modification recorded on 9/23/2005 as Instrument MO5-64979 in the mortgage records of Klamath County, Oregon.
