### PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE made this 1st day of July, 2025, by and between

**Gloria Henneman the duly appointed, qualified and acting Personal Representative of the Estate of Emma Maxine Collier, deceased, Probate Case No.25PB04111, filed in Klamath County, State of Oregon,**

hereinafter called the first party, and

**Brooklynn Budden and Patrick Budden as Tenants by the Entirety**

hereinafter called the second party.

#### WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

**The Easterly 5 feet of Lot 17, All of Lots 18 and 19 and the Westerly 15 feet of Lot 20, Block 12, Mountain View Addition to the City of Klamath, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.**
