I. MODIFICATION OF DEED OF TRUST.

A. The paragraph entitled "FOR THE PURPOSE OF SECURING" is hereby replaced with the following:

The foregoing shall hereinafter collectively be referred to as the "Indebtedness". The continuing validity and priority of this Deed of Trust as security for future loans or advances shall not be impaired by the fact that at certain times hereafter there may exist no outstanding indebtedness from Grantor to Beneficiary or no commitment to make loans or advances.
