LEASE AGREEMENT

THIS LEASE ("Lease") was entered into as of August 1, 2025 ("Effective Date") by and between OREGON CONFERENCE ADVENTIST CHURCHES, an Oregon non-profit corporation ("Lessor") and OREGON CONFERENCE OF SEVENTH-DAY ADVENTISTS, an Oregon non-profit corporation ("Lessee").

LEASED PREMISES

1. The Lessor hereby leases to Lessee and the Lessee hereby leases from Lessor the property located in the city of Bonanza, County of Klamath, State of Oregon, being more particularly described by the legal description on Exhibit A attached hereto and made a part hereof (hereinafter called the "Leased Property"). The Lessor covenants and warrants to the Lessee that it is the fee simple owner of the Leased Property.

TERM

2. The initial term of this Lease (the "Lease Term") shall be fifty (50) years commencing on the date (the "Effective Date") of this Lease Agreement.

CONSIDERATION

- 3. Lessee shall pay all real and personal property taxes on the Leased Property when they come due, and provide Lessor confirmation, and/or will file for property tax exemption as a non-profit organization, and provide Lessor confirmation of the status of the exemption. Lessor and Lessee agree that any tax savings resulting from the exemption from taxation granted under ORS 307.166 will inure solely to the benefit of Lessee.
- 4. Lessee shall maintain the property in good repair at all times during the Lease term, and may make such capital improvements on the property as Lessee determines desirable, at the expense of the Lessee.

5. Lessee shall pay all other expenses related to this property, including insurance, utilities, fees or other assessments that may be levied on the property by reason of Lessee's use thereof.

<u>USE</u>

6. The Leased Property may only be used for the development, construction and/or use of the existing buildings thereon, for the Bonanza Seventh-day Adventist Church, and all activities related to its mission of advancing the Seventh-day Adventist faith under the control and direction of the Oregon Conference of Seventh-day Adventists, consistent with the policies and guidelines of the Seventh-day Adventist Church denominational organization (the "Permitted Use").

TERMINATION

7. This Lease Agreement may be terminated prior to the expiration of the Lease Term only on the mutual written agreement and consent of both parties.
