KNOW ALL MEN BY THESE PRESENTS, That as **KLAMATH ADVOCACY CENTER, an Oregon Non-Profit Corporation** formerly known as **KLAMATH CRISIS CENTER LTD, an Oregon non-profit Corporation**, as to **Parcel 1** and **KLAMATH ADVOCACY CENTER, an Oregon Non-Profit Corporation** formerly known as **KLAMATH CRISIS CENTER, an Oregon non-profit Corporation**, as to **Parcel 2**

hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto **KLAMATH ADVOCACY CENTER an Oregon Non-Profit Corporation,**

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:


