**TERMINATION AND RELEASE OF
SOLAR ENERGY LEASE AND PURCHASE OPTION AGREEMENT**

THIS TERMINATION AND RELEASE OF SOLAR ENERGY LEASE AND PURCHASE OPTION AGREEMENT (this “Termination”) is made effective as of this 13th day of November 2025 (the “Effective Date”), by and between **Green Diamond Resource Company**, a Washington corporation (“Lessor”), whose address is 1301 5th Avenue, Suite 2700, Seattle WA, 98101, and **ACE DevCo NC, LLC**, a Delaware limited liability company (“Lessee”), whose address is 2180 South 1300 East, Suite 500, Salt Lake City, UT 84106.

RECITALS

WHEREAS, Lessor and Lessee are parties to that certain Solar Energy Lease and Purchase Option Agreement (the “Agreement”) dated December 19, 2024, pursuant to which Lessor granted to Lessee the option to lease certain lands in Klamath County, Oregon, as more specifically described in the Agreement.

WHEREAS, Lessor and Lessee recorded a Memorandum of Solar Energy Lease and Purchase Option Agreement (the “Memorandum”), which set forth certain terms and conditions of the Agreement, in the Official Public Records of Klamath County, State of Oregon (“Official Records”), on February 11, 2025, as Document # 2025-000911, in order to provide record notice of the Agreement and Lessee’s rights in and to the Property.

WHEREAS, Lessee has the unilateral right to terminate the Solar Energy Lease and Purchase Option Agreement pursuant to the terms thereof and has been so terminated;

WHEREAS, this Termination is entered into for the purpose of setting forth in the public record of Klamath County, Oregon that the Solar Energy Lease and Purchase Option Agreement has been terminated and accordingly, the Memorandum is to be hereby terminated.

NOW THEREFORE, the Memorandum is hereby terminated, fully released and is of no further force and effect as of the Effective Date hereof.


