WARRANTY DEED

KNOW ALL BY THESE PRESENTS that WILLIAM GOODIN who acquired title as WILLIAM D. GOODIN and JUDITH GOODIN who acquired title as JUDITH K. GOODIN, hereinafter called grantor, for the consideration hereinafter stated, do hereby grant, bargain, sell and convey unto WILLIAM GOODIN AND JUDITH GOODIN, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE GOODIN LIVING TRUST DATED OCTOBER 30, 2025, AND ANY AMENDMENTS THERETO, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in **Klamath** County, State of Oregon, described as follows, to-wit:

Lot 20 in Block 8, TRACT 1064, FIRST ADDITION TO GATEWOOD, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

And grantor hereby covenants to and with grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except: NONE, and that grantor will warrant and forever defend the premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ 0.00. However, the actual consideration consists of or includes other property or value given or promised which is the whole consideration.

In construing this deed, where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this deed shall apply equally to corporations and to individuals.

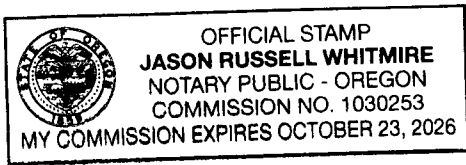
