**STATUTORY WARRANTY DEED**

The Klamath Tribes, a federally recognized Indian Tribe of the State of Oregon, **Grantor**, conveys and warrants to The United States of America in Trust for the Klamath Tribes of Oregon, **Grantee**, the following described real property free of encumbrances, except as specifically set forth herein situated in Klamath County, Oregon, to with: (Hog Creek Ranch Property)

Parcel 1: E1/2 of the NE1/4 of the SW1/4 and NE1/4 of the SE1/4 of the SW1/4 of Section 1, Township 33 South, Range 8 East, Willamette Meridian, Klamath County, Oregon (29.94 acres)

Parcel 2: SE1/4 of the NW1/4 and the E1/2 of the NW1/4 of the NW1/4 Section 7, Township 33 South, Range 9 East, Willamette Meridian, Klamath County, Oregon (59.85 acres).

Parcel 3: The S1/2 of the SE1/4 of the SW1/4, Section 1, Township 33 South, Range 8 East, Willamette Meridian, Klamath County, Oregon (20.12 acres).

Parcel 4: The S1/2 of the NW1/4 of the NW1/4, Section 1, Township 33 South, Range 8 East, Willamette Meridian, Klamath County, Oregon (21.37 acres).


