The true and actual consideration for this transfer is estate distribution.

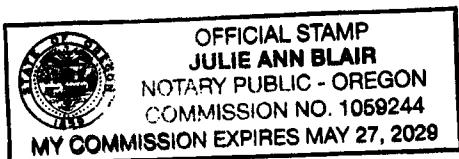

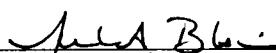
