






EXHIBIT A

Beginning at a point on the East and West center section line of Section 12, Township 39 South Range 8 East of the Willamette Meridian, 330 feet west of the center of said Section 12; thence North and parallel to the west line of the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 12 a distance of 660 feet; thence West and parallel to the South line of said SE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 12 a distance of 165 feet; thence South and parallel to the west line of said SE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 12 a distance of 660 feet; thence East on the East and West center line of said Section 12 a distance of 165 feet to the place of beginning, SAVING AND EXCEPTING a strip of land 30 feet in width along the East and West center line of said Section 12 to be used for road purposes.
