All of Block 7, Hessig Addition to Fort Klamath, according to the official plat thereof on file in the office of Clerk of Klamath County, Oregon.

Together with that portion of vacated Emmitt Street and vacated 6th Street as disclosed by Order Granting Vacation recorded in Volume M-95 at Page 19420 which inurred thereto.

The true consideration for this conveyance is to convey title.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
