**NOTICE OF CLAIM OF LIEN ORS 545.494**

NOTICE IS HEREBY GIVEN that Klamath Irrigation District (KID), 6640 KID Lane, Klamath Falls, Oregon 97603, claims a lien pursuant to ORS 545.494 against the parcels of real property situated in Klamath County, Oregon more particularly described on Exhibit A attached hereto and incorporated herein by this reference.

The liens are claimed for delinquent water delivery charges and assessments, interest, and lien charges owed to KID as of May 9, 2000.

The attached Exhibit A contains the following information concerning each parcel on which a lien is claimed:

- Column A: KID's account number
- Column B: The name of the water user to whom the water was delivered or was deliverable;
- Column C: The amount claimed past due;
- Columns D and E: The book or volume and page number of the records of the Clerk of Klamath County, Oregon in which the legal description of the parcel is recorded.

The amounts owed to KID earn interest at the rate of 1.33 percent per month from June 1, 2000 until paid.

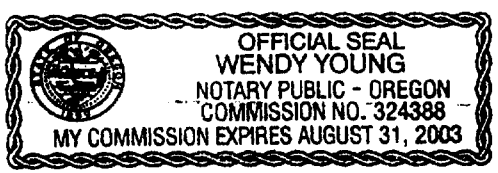
